#### I. Curriculum Committee Report

Since the Senate was worried about reaching quorum due to department meetings being held at the same time, the first item on the Agenda was the Curriculum Committee Report.

Chairperson Kahn reviewed the Fall 2011 Opening Sessions workshop on the Senate. The panel consisted of four past Presidents of the Senate (Bob Kahn, Lynne Teplin, Janice Karlen, Jerry Ianni).

# IV. Update on Budget by VP Richard Elliott

Vice-President of Administration, Richard Elliott, and Executive Director of Finance & Business, Thomas Hladek, provided an update on the Budget.

They covered additional allocations for FY 2012 including mandatory increases in the budget, strategic plan increases, and college wide construction initiatives.

# V. Pathways Discussion

Scott White, Valerie Taylor-Haslip, Elizabeth Beck (student) provided a briefing on the CUNY Pathways project. They provided a background for the development of the CUNY Pathways project, discussed the reasons for using Learning Outcomes, and outlined the role of the

LaGuardia Working Committee. They discussed their outreach to the LaGuardia community, and their plans to collect feedback, including an online Jam and hosting a Blog.
