II. Approval of the Minutes of March 6^h, 2019

V. Report from the CUNY University Advisory Council for Diversity. - Natalie Havlin

Natalie Havlin, LaGuardia's representative on the CUNY University Advisory Council on Diversity (UACD), Made a presentation where she summarized the Advisory Council's Diversity Action Plan, highlighting the following points:

- -Although there is increased hiring of underrepresented groups, these numbers have not had an overall effect on the number of minority faulty due to people leaving.
- The Advisory Council has proposed the idea to have an initiative from the Senate to create a diversity committee to follow up on the issues relating to faculty retention and hiring.

VI. Budget Matters and Queries Vice President - Shahir Erfan and Thomas Hladek

Presented the third-Quarter Financial Report; there is a projected deficit of approx. 3 million dollars.

Reduction 6.8 million for all colleges, projection 3.5 million dollars for all community colleges

State and federal dollar will be cut.

A discussion regarding the process by which the budget priorities are determined ensued. The Budget committee, including the Senate, with other constituencies, can give feedback only after the budget has been determined.
